# Europe's largest LEZ Rhine/Ruhr

More and more local authorities are taking action and setting up low emission zones to enable them to comply with the EU clean air directive 2008/50/EC. More than 70 cities in Germany have set up a low emission zone (LEZ) and vehicles without a LEZ-sticker or with a red LEZsticker are neither allowed to enter nor park within these designated zones. As of May 2014 nationwide, violators will be ticketed with an increased 80 Euro fine.

As of the 1<sup>st</sup> of July, 2014, Europe's largest LEZ Rhine/Ruhr has tightened up their entry requirements. More than 20 cities have now switched to the "green-LEZ", which allows access to vehicles with a green LEZsticker only to any environmental zone within North Rhine/Westphalia.

# Save on toll charges in Germany

Since 1<sup>st</sup> August 2012, Germany's truck toll system has been extended to cover numerous four-lane national highways right across the country, in addition to the entire motorway network. Retrofitting Euro II and Euro III vehicles with HJS diesel particulate filter systems is rewarded in Germany with lower motorway toll charges. And truck operators from outside Germany can also save by fitting a particulate filter.

## State subsidies to encourage retrofitting\*

German haulage companies that modernise their fleets and fit diesel particulate filters to their trucks can apply for state subsidies known as 'de-minimis' aid.
